## Description:

- Part I is an overview of the 1P2P model. This webinar explains where the model came from, how it evolved from the pre-2020 1P1P model, what it does and does not do, and how you can use it.
- The presenters will explain how 1P2P can stand alone as the unified model of response for an institution but will make the case for why two procedures are likely better than just one under the current regulations.
- For those who want to simplify one process, the presenters will also explain how this can be done.
- The value of a unified policy will be explained, with respect to Titles VII and IX, within the model's approach to applying the same policies and procedures to all faculty, students, and staff.
- The advantage of addressing all forms of discrimination within one set of uniform policies will be discussed in terms of equity and consistency.

## Description:

## Today's Topic: 1P2P Webinar Part 3: Procedures

Part III of this webinar series focuses on the Procedures of 1P2P, including both Process A and Process B. The presenters will show how 1P2P functions as a user-guide, both for those involved in the grievance process and those who administer it. Do procedures need to be this descriptive? We'll discuss the balance the authors struck in terms of what is covered and what is left to the discretion of those who administer the process. The result is a balanced and flexible approach that is transparent to the end-user. We'll talk about ways to enhance the user-friendliness of 1P2P and how to make the complex approaches designed by the OCR as accessible as possible for members of your community. We'll discuss ways that 1P2P can be modified, adapted, and made to suit the needs of individual institutions.
